

DAMN GOOD NOISE: ENTER YOUR ALBUM OR EP ON CD

Damn Good Noise accepts entries from established musicians for full or partial play at a listening event or for sale in our upcoming online music store. We accept music from self produced artists or from independent labels.

Damn Good Noise: Listen-in (DGN:L-i) is a unique concept in music appreciation launched at a hip Manhattan lounge in 2005. It is an album listening party that brings the community back into the listening experience. "People hang out with their friends and drink responsibly," says Ellenbogen, the founder of DGN. "It is a powerful way to introduce new music, art, fashion, accessories and other goods and services to a targeted audience."

A DGN:L-i event is a program of recently or soon to be released albums or EPs played in full. Art, fashion, and other accessories are curated alongside the music at different venues. www.damngoodnoise.com gives people the information they need to know about the bands and the labels – complete with links to their respective websites. Articles and interviews can be found on the site too.

Print, fill out and sign the agreement/submissions form on page 2 and be sure to follow these instructions.

Please cut out the 2 forms at the bottom of this page and write clearly; then tape to the cover of 2 CDs.

Please be sure the CDs are published with the band name and song titles included!

One well-placed piece of tape is sufficient. You will not be graded on your scissor skills.

If your CD is in a cardboard or paper case, put the form on the back. Do not tape it directly to the cover art.

Do not send a cover letter, press release or any photos.

Please do not over-package your submission. A simple padded bubble envelope will do. Additional tape, bubble wrap or sealed boxes make it harder for us to get to your music.

Please remove any shrink wrap from your CD.

We will email a notice of receipt to the address supplied. Wait. Please do not write or call us as we get so many CDs and listen to a sample of everything that hits our Ipod. However, we cannot guarantee that we will listen to your entire CD or put your music in a DGN:L-i event.

If your work is selected, we will call or e-mail you before programming your CD into a show.

Because of staff limitations, we are unable to contact artists who are not selected. We are also unable to return CDs.
